
# IPC Private Wealth Visio Income Pool

This Pool provides access to professional portfolio managers who invest in a relatively smaller, concentrated set of equities and a select portfolio of investment grade bonds, and provides enhanced diversification through international ETF holdings. Beutel Goodman, the active equity sub-advisor, selects a concentrated set of high-quality companies generating substantial free-cash flow, that provide significant long-term capital growth potential, with a central focus on risk mitigation and capital preservation. The Pool's asset class weightings will generally be 30% to 50% in equity securities and 50% to 70% in fixed-income securities. We maintain the optimal target mix by strategically and automatically rebalancing the Pool regularly.




