Management Discussion of Fund Performance

November 13, 2023

This Management Discussion of Fund Performance presents the views of Counsel Portfolio Services Inc. ("Counsel") on the significant factors and developments during the period ended September 30, 2023 that have affected the Fund's performance and outlook. For information on the Fund's longer-term performance, please refer to the *Past Performance* section of the report.

In addition, net asset value (NAV) refers to the value of the Fund or a series, as calculated for transaction purposes, on which the discussion of Fund performance is based.

Results of Operations

Investment Performance

During the year, the Fund's Series A securities returned -9.81% (after deducting fees and expenses). This compares with a 0.74% return of the broad-based MSCI World Total Return Index and a -1.81% return of the mandate-specific MSCI World Small Cap Total Return Index. All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses, and commissions, none of which are reflected in the index returns.

During the six-month period, the Fund's Series A securities returned 0.58% (after deducting fees and expenses). This compares with a 3.03% return of the broad-based MSCI World Total Return Index and a -1.41% return of the mandate-specific MSCI World Small Cap Total Return Index. All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses, and commissions, none of which are reflected in the index returns.

Global equities rose over the period as central banks slowed the pace of their rate increases. The global economy proved resilient, and employment remained strong. With high inflation persisting, the U.S. Federal Reserve, European Central Bank and Bank of England increased their policy interest rates, albeit at a slower pace. Higher interest rates and inflation contributed to tight financial conditions, which weighed on demand and hindered manufacturing sector activity. Global small-capitalization stocks generally underperformed large-capitalization stocks. Within the MSCI AC (All Country) World Small Cap (Net) Index, Egypt, Hungary and Turkey were the strongest-performing markets, while China, Sweden and Thailand were the weakest. The Energy, Financials and Industrials sectors were the strongest performers, while Utilities, Communication services and Health care were the weakest.

The Fund underperformed the broad-based index as small capitalization securities broadly underperformed global equity markets. The broad-based index is designed to measure the performance of the overall developed large cap equity markets, whereas the Fund invests with a focus on small cap equities. Given the Fund's composition, the mandate-specific index provides a more meaningful comparison for relative performance.

The Fund outperformed the mandate-specific index due to its global ex. Canada mandate sub-advised by Wasatch primarily due to security selection within the Information Technology and Health Care sectors. Allocation decisions related to the United States and United Kingdom, also contributed to performance. The Fund's Canadian mandate, sub-advised by Mackenzie Investments, also detracted due to being underweight Energy and stock selection within the Financials, Utilities, and Consumer Discretionary sectors.

During the period, the Euro ("EUR"), Japanese Yen ("JPY"), and British Pound ("GBP") depreciated 2.17%, 10.85%, and 1.29% respectively against the Canadian dollar ("CAD") detracting from the Fund's performance. Selected partial hedging positions held against the EUR and GBP, held during the period, served to slightly

offset this impact. The U.S. dollar ("USD") appreciated 0.36% against the CAD contributing the Fund's performance. As of period-end, the Fund maintained a target hedge of 25.0% against the GBP but was otherwise unhedged.

Net Assets

The Fund's NAV declined by \$16.4 million, or 8.2%, to \$183.5 million as at September 30, 2023, from \$199.9 million as at March 31, 2023. Of this decrease, \$19.6 million was attributable to net redemptions and slightly offset by a \$3.2 million increase due to investment performance (after deducting fees and expenses).

Fees and Expenses

The annualized management expense ratio ("MER") for each series during the period ended September 30, 2023, was generally similar to the MER for the year ended March 31, 2023. Total expenses paid vary from period to period mainly as a result of changes in average assets in each series. The MERs for all series are presented in the *Financial Highlights* section of this report.

Recent Developments

Wasatch, the global sub-advisor, notes that, in many ways, the third-quarter market environment seemed similar to 2022, though less severe. As central banks indicated they will likely keep interest rates higher for longer, bond yields rose and global equities lost ground. Also mirroring 2022, value stocks outperformed growth stocks, large-cap stocks outperformed small-caps, and the energy sector was one of the few bright spots within equity markets. These trends were headwinds to small-cap relative performance in the third quarter. While uncertainty remains about just how long the Federal Reserve and other central banks will keep rates high, the global sub-advisor believes we're near the top of the interest-rate cycle and doesn't expect a large valuation reset for growth stocks. Instead, investors' attention may turn to companies that can thrive in a higher for longer interest-rate environment.

Mackenzie, the Canadian sub-advisor, notes that small caps continue to be under appreciated given tough sentiments, with recession fear disproportionately weighing on the sector. They continue to observe above average volatility and the more likely hard landing scenario. Under this backdrop, the sub-advisor believes issuers exposed to infrastructure spending and energy transition will be more resilient in the short term, however in the long run, the consumer and financial sectors will rebound as the pivot point is approached. Companies that emphasize a conservative capital allocation strategy, with lots of current free cash flow generations, have proven to win in the long run.

On April 3, 2023, The Canada Life Assurance Company announced an agreement to acquire Investment Planning Counsel Inc. (the parent company of Counsel). The transaction is expected to be completed prior to the end of 2023. During the initial period following completion of the transaction, Counsel will continue to operate as manager of the Counsel Funds and no material changes to the Fund's operations are expected. However, there will be changes to the membership of the Fund's Independent Review Committee and Counsel's Board of Directors in connection with the completion of the transaction.

In October 2023, Counsel reduced its period-end 25% hedge against the GBP to 12.5% and also introduced a 45% hedge against the USD. Currency hedging is dynamic and may vary between 0-100% at our discretion based on our assessment of currency market conditions.

Related Party Transactions

Management Fees

The management fee for each applicable series is calculated and accrued daily as a percentage of its NAV. The Fund's management fees were used by the Manager to pay for: costs of managing the investment portfolio; providing investment analysis and recommendations; making investment decisions; the purchase and sale of the investment portfolio; and providing other services. The Manager also

used the management fees to fund trailing commissions and other compensation (collectively, "Distribution Related Payments") paid to registered dealers and brokers whose clients invest in the Fund.

The following dealers affiliated with Counsel may be entitled to Distribution Related Payments from Counsel on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation, Investors Group Financial Services Inc., and Quadrus Investment Services Ltd.

Counsel used approximately 41% of the total management fee revenues received from all Counsel funds to fund Distribution Related Payments to registered dealers and brokers. In comparison, such Distribution Related Payments for the Fund represented 39% of the management fees paid. This amount is an average percentage of the management fees paid by all series. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions paid for that series.

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to Counsel at the annual rates specified under *Series Information* in this report and as more fully described in the Simplified Prospectus. In return for the administration fees, Counsel pays all costs and expenses (other than certain specified fund costs) required to operate the Fund. See also *Management Fees*.

Other Related Party Transactions

Other investment funds managed by Counsel ("Top Funds") invest in Series O securities offered by the Fund on a prospectus-exempt basis in accordance with the investment objectives of those funds. Series Private Wealth securities are issued on a prospectus-exempt basis to investors in discretionary managed account programs offered by IPC Securities Corporation, an affiliate of Counsel. As a result of these investments, the Fund is subject to large transaction risk as discussed in its Simplified Prospectus. Counsel manages this risk to reduce the possibility of any adverse effect on the Fund or on its investors, through such processes as requiring advance notice of large redemptions. At September 30, 2023, Top Funds owned 62.1% of the Fund's NAV and Series Private Wealth investors owned 24.4% of the Fund's NAV. As of September 30, 2023, Counsel had not received notice of any large redemptions. All related party transactions are based on the NAV per security on each transaction day.

During the period, the Fund did not rely on an approval, positive recommendation, or standing instruction from the Counsel Funds' Independent Review Committee ("IRC") with respect to any related party transactions.


Past Performance






Year-by-Year Returns



(1) Series A is the only series subject to sales or redemption charges; these charges are based on purchase options chosen. Securities purchased under the sales charge option may be subject to a negotiated fee of up to 5% at time of initial purchase. Securities previously purchased under the redemption charge purchase option may be subject to a redemption fee of up to 4.0% (based on date of initial purchase); new securities are not available under this option but may be acquired through switching from other Counsel funds. Effective June 15, 2022, the series' management fee was increased from 1.95% and the administration fee was reduced from 0.31%.

(2) A negotiable advisory or asset-based fee (plus sales taxes) is payable by investors to their dealer(s) in connection with the securities held in this series. The fee may be collected by Counsel from the investor's account through redemption of securities and remitted to the dealer at the investor's request. Alternatively, the dealer may collect it directly from the investor. Effective June 15, 2022, the series' management fee was reduced from 1.10% (including Series I management fee which is charged directly to investors).

(3) The management fee for this series is 1.00% and is payable directly to Counsel generally through the monthly redemption of securities.

(4) There are no management or administration fees for this series since these securities are designed to facilitate fund-of-fund investing where duplication of management fees is prohibited.

(5) There are no management fees for Series Private Wealth. An investor must enter into an agreement to participate in a discretionary managed program offered by IPC Securities Corporation and agree to pay certain asset-based fees.

(6) Counsel may, at its discretion, waive or lower the management fee (either directly or indirectly) and/or administration fee payable by investors. Individual investors may be eligible for a management fee reduction subject to meeting certain requirements as discussed in the Fund's Simplified Prospectus.
