Management Discussion of Fund Performance

June 4, 2025

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments that have affected the performance and outlook of Counsel Conservative Portfolio (the "Fund") in the financial year ended March 31, 2025 (the "period"). If the Fund was established during the period, "period" represents the period since inception.

In this report, "CLIML" and "the Manager" refer to Canada Life Investment Management Ltd., which is an indirect, wholly owned subsidiary of The Canada Life Assurance Company ("Canada Life"). From the beginning of the period until September 30, 2024, Counsel Portfolio Services Inc. ("Counsel") was the manager of the Fund. On October 1, 2024, Counsel was amalgamated with CLIML, whereupon CLIML, which is the amalgamated company, became the Fund's Manager. The Manager has entered into a fund administration agreement with Mackenzie Financial Corporation ("Mackenzie"), an affiliate of the Manager and Canada Life, for administrative services. In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

Investment Objective and Strategies

The Fund seeks a balance between income and capital growth by investing in securities of a variety of global equity and fixed income mutual funds. The Fund's asset class weightings will generally be 50%-70% in fixed income securities and 30%-50% in equity securities.

Risk

The risks of the Fund remain as discussed in the Fund's Simplified Prospectus.

The Fund is suitable for medium-term investors looking for a global balanced fund to hold as a key part of their portfolio, who can handle the volatility of stock and bond markets, and who have a low to medium tolerance for risk.

Results of Operations

Investment Performance

The performance of all series in the current and previous periods is shown in the *Past Performance* section of the report. Performance will vary by series primarily because fees and expenses differ between series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Series Information* section of this report for the varying management and administration fees payable by each series. The following comparison to market indices is intended to help investors understand the Fund's performance relative to the general performance of the markets. However, the Fund's mandate may be different from that of the indices shown.

During the period, the Fund's Series A securities returned 7.1% (after deducting fees and expenses paid by the series). This compares with a return of 10.3% for a blended index composed of a 60% weighting in the Fund's broad-based index, the FTSE Canada Universe Bond Index (returned 7.7%), a 33.3% weighting in the MSCI World (Net) Index (returned 13.7%) and a 6.7% weighting in the S&P/TSX Composite Index (returned 15.8%). All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, which are not reflected in the index returns.

Global equity market performance was mixed over the period in response to shifting expectations regarding central bank monetary policy and geopolitical tensions. Rate cuts by the U.S. Federal Reserve and the European Central Bank helped investor sentiment in the United States and Europe. Currency movements generally boosted returns in Canadian dollar terms. Canadian equities rose despite volatility, with record-high gold prices supporting mining stocks and declining interest rates helping bank stocks. Canada's unemployment rate rose to 6.6%, highlighting labour market weakness. In response to weak economic data, the Bank of Canada reduced its policy rate seven times to 2.75% from 5.00%.

Within the MSCI World (Net) Index, Africa and the Middle East and North America were the best-performing regions in Canadian dollar terms, while Japan and Asia Pacific (ex Japan) were the weakest. The financials, utilities and communication services sectors were the strongest performers, while materials, health care and consumer discretionary were the weakest.

Within the S&P/TSX Composite Index, materials, financials and information technology were the best-performing sectors, while health care, communication services and industrials were the weakest.

The Fund underperformed the broad-based index, with its allocation to small-capitalization stocks detracting from performance. Given the Fund's mandate, the return of the blended index is a more meaningful comparison.

The Fund underperformed the blended index. The Fund's asset allocation had no significant impact on performance, while the selection of underlying funds within each asset class detracted from performance.

Among the underlying funds in the portfolio, the largest detractor from relative performance was Counsel Enhanced Global Equity (representing 2.9% of net assets at period-end).

The largest contributors to relative performance were Counsel Multi-Factor U.S. Equity, Counsel Fixed Income and Counsel Multi-Factor International Equity (respectively representing 8.3%, 55.1% and 4.9%).

During the period, the Manager increased the Fund's allocations to its underlying multi-factor funds and growth funds to boost exposure to the factors that drive broad market performance. The allocations to Counsel Canadian Value, Counsel U.S. Value and Counsel International Value were eliminated, but the Fund retained value factor exposure through its holdings in multi-factor funds. An allocation was added to Counsel Enhanced Global Equity, a liquid alternatives strategy.

During the period, the U.S. dollar ("USD"), euro ("EUR"), Japanese yen ("JPY") and British pound ("GBP") appreciated 6.20%, 6.51%, 7.25% and 8.72%, respectively, relative to the Canadian dollar ("CAD"), contributing to the Fund's performance. Selected hedging positions held in the underlying equity funds against the USD slightly offset this impact. At period-end, the underlying equity funds were not hedged against those currencies.

Net Assets

The Fund's net assets decreased by 10.4% during the period to \$206.7 million. This change was composed primarily of \$17.1 million in net income (including any interest and/or dividend income) from investment performance, after deducting fees and expenses, and a decrease of \$41.0 million due to net securityholder activity (including sales, redemptions and cash distributions).

On May 23, 2025, \$47.0 million flowed into the Fund due to merger activity.

Fees and Expenses

The management expense ratio ("MER") for each series during the year ended March 31, 2025, was generally similar to the MER for the year ended March 31, 2024. Total expenses paid vary from period to period mainly as a result of changes in average assets in each series. The MERs for all series are presented in the *Financial Highlights* section of this report.

Recent Developments

Even amid the tariff-driven economic slowdown, the Manager continues to expect slow but positive growth in 2025. The Manager believes the spring 2025 global equity correction shares characteristics with past episodes when inflationary pressures and restrictive trade policies dampened sentiment, leading to weakness before eventual stabilization. Thus, the Manager maintains a positive long-term outlook for equities. However, escalating trade tensions have led the Manager to lower its expectations for U.S. equities, while recognizing the potential for recovery once macroeconomic fears abate. Given the ongoing market uncertainty, the Manager has emphasized the Fund's sector diversification to mitigate risk and maintain long-term exposure to cyclical recovery opportunities.

The underlying equity funds continue to be generally unhedged against foreign currencies. Currency hedging is dynamic and may vary between 0% and 100% at the Manager's discretion based on its assessment of currency market conditions.

Effective October 1, 2024, the manager, trustee, portfolio manager and promoter of the Fund, Counsel, amalgamated with CLIML, whereupon the amalgamated company, named CLIML, continued to serve as the manager, trustee, portfolio manager and promoter of the Fund.

The merger of Counsel Retirement Preservation Portfolio into the Fund was approved by investors on May 12, 2025, and took effect on May 23, 2025. The Manager does not consider this merger to be a material change for the Fund's investors.

Related Party Transactions

Management Fees

The management fee for each applicable series is calculated and accrued daily as a percentage of its NAV. The Fund's management fees were used by the Manager to pay for the costs of managing the investment portfolio, including providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sale of the investment portfolio, and providing other services.

The Manager is responsible for paying certain administrative costs and all trailing commissions and any other compensation (collectively, "distribution-related payments") paid to registered dealers and brokers whose clients invest in the Fund. The following dealers affiliated with the Manager may be entitled to distribution-related payments from the Manager on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation, Investors Group Financial Services Inc. and Quadrus Investment Services Ltd.

The Manager used approximately 40% of the total management fee revenues received from all funds managed by CLIML to fund distribution-related payments to registered dealers and brokers. In comparison, such distribution-related payments for the Fund represented on average 46% of the management fees paid by applicable series of the Fund during the period. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions paid for that series. As Series E of this Fund pays lower management fees than Series A of most other funds managed by the Manager, while paying the same trailer fee, distribution-related payments make up a higher proportion of the Fund's management fee compared to other funds managed by the Manager.

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to the Manager at the annual rates specified under *Series Information* in this report and as more fully described in the Simplified Prospectus. In return for the administration fees, the Manager pays all costs and expenses (other than certain specified fund costs) required to operate the Fund that are not included in the management fees. See also *Management Fees*.

Other Related Party Transactions

During the period, the Manager relied on standing instructions from the Counsel Funds' Independent Review Committee ("IRC") with regard to asset reallocations. The Manager also relied on a positive recommendation issued by the IRC to proceed with an asset mix change that resulted in the redemption of the underlying funds Counsel Canadian Value, Counsel U.S. Value and Counsel International Value on September 4, 2024.

The Manager relied on a positive recommendation issued by the Counsel Funds' Independent Review Committee to proceed with the merger of Counsel Retirement Preservation Portfolio into the Fund on May 23, 2025.


Past Performance








The FTSE Canada Universe Bond Index is a broad measure of Canadian bonds with terms to maturity of more than one year. It includes federal, provincial, municipal and corporate bonds rated "BBB" or higher.

The MSCI World (Net) Index represents large- and mid-cap equity performance across 23 developed markets. Net total returns are calculated after the deduction of withholding tax from the foreign income and dividends of its constituents.

The S&P/TSX Composite Index is a capitalization weighted index that represents some of the largest float adjusted stocks trading on the Toronto Stock Exchange.

Securities previously purchased under the redemption charge purchase option may be subject to a redemption fee of up to 3.5% (based on date of initial purchase); new securities are not available under this option but may be acquired through switching from other Counsel funds.
- (2) A negotiable advisory or asset-based fee (plus sales taxes) is payable by investors to their dealer(s) in connection with the securities held in this series. The fee may be collected by the Manager from the investor's account through redemption of securities and remitted to the dealer at the investor's request. Alternatively, the dealer may collect it directly from the investor.
- (3) The management fee for this series is equal to that of Series F but is payable directly by the investor to the Manager rather than by the Fund, generally through the monthly redemption of securities.
- (4) There are no management fees for Series Private Wealth. An investor must enter into an agreement to participate in a discretionary managed program offered by IPC Securities Corporation and agree to pay certain asset-based fees.
- (5) The Manager may, at its discretion, waive or lower the management fee (either directly or indirectly) and/or administration fee payable by investors. Individual investors may be eligible for a management fee reduction subject to meeting certain requirements as discussed in the Fund's Simplified Prospectus.
- (6) This series is no longer available for sale. The series' original start date was May 25, 2017. On October 27, 2023, Series Private Wealth I securities were redesignated as Series F securities, resulting in a consolidation of these series' assets.
- (7) This series is not available for purchase.
- (8) This series is designed for investors who want to receive a monthly cash distribution at an annualized rate of up to 6% per year.
