Management Discussion of Fund Performance

November 8, 2024

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments that have affected the performance and outlook of Counsel Growth Portfolio (the "Fund") in the six-month period ended September 30, 2024 (the "period"). If the Fund was established during the period, "period" represents the period since inception.

During the period, "Manager" refers to Counsel Portfolio Services Inc. ("Counsel"), which is a subsidiary of The Canada Life Assurance Company ("Canada Life"). On October 1, 2024, Counsel was amalgamated with Canada Life Investment Management Ltd. ("CLIML"), whereupon the amalgamated company, named CLIML, continued as the Fund's Manager. The Manager has entered into a fund administration agreement with Mackenzie Financial Corporation ("Mackenzie"), an affiliate of the Manager and Canada Life, for administrative services. In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

Results of Operations

Investment Performance

The performance of all series in the current and previous periods is shown in the *Past Performance* section of the report. Performance will vary by series primarily because fees and expenses differ between series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Series Information* section of this report for the varying management and administration fees payable by each series. The following comparison to market indices is intended to help investors understand the Fund's performance relative to the general performance of the markets. However, the Fund's mandate may be different from that of the indices shown.

During the period, the Fund's Series A securities returned 6.4% (after deducting fees and expenses paid by the series). This compares with a return of 8.5% for a blended index composed of a 66.7% weighting in the Fund's broad-based index, the MSCI World (Net) Index (returned 9.0%), a 20% weighting in the FTSE Canada Universe Bond Index (returned 5.6%) and a 13.3% weighting in the S&P/TSX Composite Index (returned 10.0%). All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, which are not reflected in the index returns.

Global equity markets generally rose over the period as most central banks began to cut interest rates. Share prices increased in relation to corporate earnings, with gains in U.S. markets driven mainly by a small number of mega-capitalization stocks. The global economy was resilient as inflation continued to slow across most major markets, although unemployment moved slightly higher. Canadian equities rose despite volatility, with the financials sector and mining stocks leading market performance. In response to weak economic data and falling inflation, the Bank of Canada reduced its policy rate three times, to 4.25% from 5.00%, and bond yields declined.

Within the MSCI World (Net) Index, Asia Pacific (ex Japan) and North America were the best-performing regions in Canadian dollar terms, while Japan, Europe, and Africa and the Middle East were the weakest. The utilities, information technology and real estate sectors were the strongest performers, while energy, consumer discretionary and health care were the weakest.

Within the S&P/TSX Composite Index, materials, utilities and financials were the best-performing sectors, while health care, industrials and energy were the weakest.

The Fund underperformed the broad-based index because of its allocation to fixed income, which underperformed equities in the period. Given the Fund's mandate, the return of the blended index is a more meaningful comparison.

The Fund underperformed the blended index. The Fund's asset allocation contributed to performance, while the selection of underlying funds within each asset class detracted from performance.

Among the underlying funds in the portfolio, the largest detractors from relative performance were IPC Multi-Factor U.S. Equity, Counsel U.S. Growth Equity and Counsel U.S. Value. IPC Multi-Factor U.S. Equity and Counsel U.S. Growth Equity respectively represented 18.3% and 18.6% of net assets at period-end, while Counsel U.S. Value was eliminated from the portfolio in the period.

The largest contributors to relative performance were Counsel Global Small Cap, Counsel International Value and IPC Multi-Factor Canadian Equity. Counsel Global Small Cap and IPC Multi-Factor Canadian Equity respectively represented 9.1% and 5.0% of net assets at period-end, while Counsel International Value was eliminated from the portfolio.

During the period, the Fund increased the allocations to its underlying multi-factor funds and growth funds to boost exposure to the factors that drive broad market performance. The Fund eliminated its exposure to value funds, including Counsel Canadian Value, but retained value factor exposure through its holdings in multi-factor funds.

During the period, the euro ("EUR"), Japanese yen ("JPY") and British pound ("GBP") appreciated 3.07%, 5.16% and 5.82%, respectively, relative to the Canadian dollar ("CAD"), contributing to the Fund's performance. The U.S. dollar ("USD") depreciated 0.14% relative to the CAD, detracting from the Fund's performance. Selected hedging positions held in the underlying equity funds against the USD slightly offset this impact. At period-end, the Fund had no hedging positions.

Net Assets

The Fund's net assets decreased by 0.2% during the period to \$410.6 million. This change was composed primarily of \$27.1 million in net income (including any interest and/or dividend income) from investment performance, after deducting fees and expenses, and a decrease of \$27.9 million due to net securityholder activity (including sales, redemptions and cash distributions).

Fees and Expenses

The annualized management expense ratio ("MER") for each series during the period ended September 30, 2024, was generally similar to the MER for the year ended March 31, 2024. Total expenses paid vary from period to period mainly as a result of changes in average assets in each series. The MERs for all series are presented in the *Financial Highlights* section of this report.

Recent Developments

Broadly, at period-end the Fund continued to hold a mild overweight position in equities and an underweight position in fixed income. The Manager believes that markets are underestimating the degree and pace of policy rate cuts by the Bank of Canada, and hence the fixed income allocation remained overweight in core Canadian bonds. Within equities, the Manager believes U.S. markets will continue to benefit from positive market sentiment toward artificial intelligence and, as such, the Fund had overweight exposure to large-cap U.S. equities. The Fund had underweight exposure to Canadian equities because the Manager believes that slowing global economic growth and investor sentiment will cause Canadian equities to lag. The neutral weighting in international equities is based on the significant dislocation in pricing between U.S. and non-U.S. companies, in the Manager's opinion.

In late October 2024, the underlying equity funds established a 20% hedge against the USD, but otherwise remained generally unhedged against foreign currencies. Currency hedging is dynamic and may vary between 0% and 100% at the Manager's discretion based on its assessment of currency market conditions.

Effective October 1, 2024, the manager, trustee, portfolio manager and promoter of the Fund, Counsel, amalgamated with CLIML, whereupon the amalgamated company, named CLIML, continued to serve as the manager, trustee, portfolio manager and promoter of the Fund.

On November 7, 2024, the Fund initiated a new investment in Counsel Enhanced Global Equity, a liquid alternatives fund managed by CLIML that provides enhanced global equity exposure when market volatility is expected to be lower.

Related Party Transactions

Management Fees

The management fee for each applicable series is calculated and accrued daily as a percentage of its NAV. The Fund's management fees were used by the Manager to pay for: costs of managing the investment portfolio; providing investment analysis and recommendations; making investment decisions; the purchase and sale of the investment portfolio; and providing other services. The Manager also used the management fees to fund trailing commissions and other compensation (collectively, "distribution-related payments") paid to registered dealers and brokers whose clients invest in the Fund.

The following dealers affiliated with the Manager may be entitled to distribution-related payments from the Manager on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation, Investors Group Financial Services Inc., and Quadrus Investment Services Ltd.

The Manager used approximately 41% of the total management fee revenues received from all Counsel funds to fund distribution-related payments to registered dealers and brokers. In comparison, such distribution-related payments for the Fund represented 41% of the management fees paid. This amount is an average percentage of the management fees paid by all series. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions paid for that series.

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to the Manager at the annual rates specified under *Series Information* in this report and as more fully described in the Simplified Prospectus. In return for the administration fees, the Manager pays all costs and expenses (other than certain specified fund costs) required to operate the Fund that are not included in the management fees. See also *Management Fees*.

Other Related Party Transactions

During the period, the Manager relied on standing instructions from the Counsel Funds' Independent Review Committee ("IRC") with regard to asset reallocations. The Manager also relied on a positive recommendation issued by the IRC to proceed with an asset mix change that resulted in the redemption of underlying funds Counsel Canadian Value, Counsel U.S. Value and Counsel International Value on September 4, 2024.

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to the Manager at the annual rates specified under *Series Information* in this report and as more fully described in the Simplified Prospectus. In return for the administration fees, the Manager pays all costs and expenses (other than certain specified fund costs) required to operate the Fund. See also *Management Fees*.

During the period, the Manager relied on standing instructions from the Counsel Funds' Independent Review Committee ("IRC") with regard to asset reallocations. The Manager also relied on a positive recommendation issued by the IRC to proceed with an asset mix change that resulted in the redemption of the underlying Counsel Canadian Value, Counsel U.S. Value and Counsel International Value on September 4, 2024.

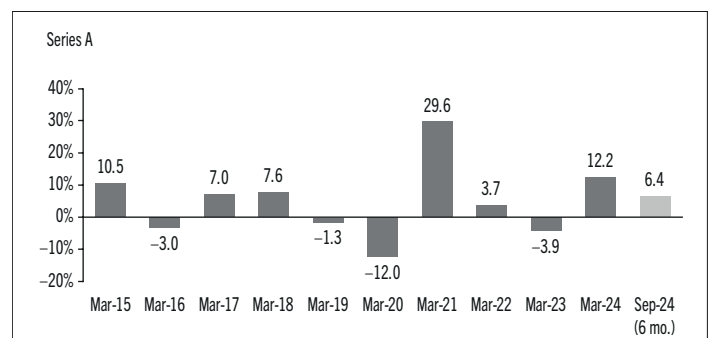
Past Performance

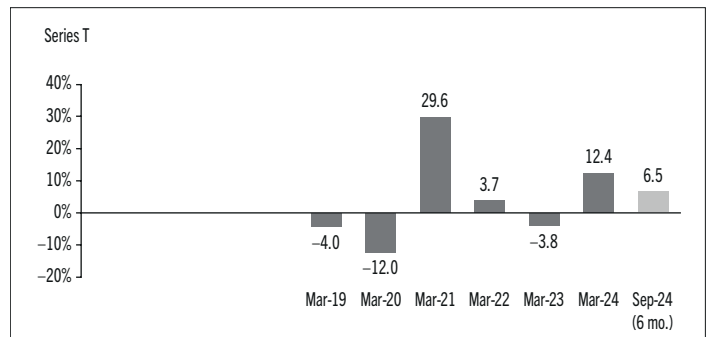
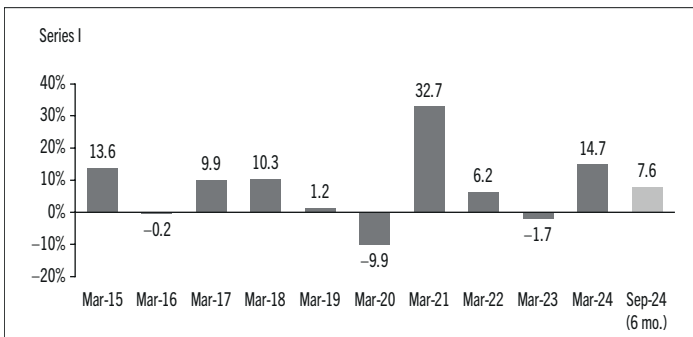
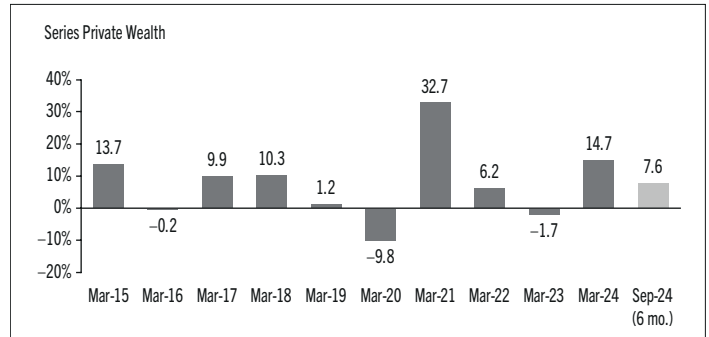
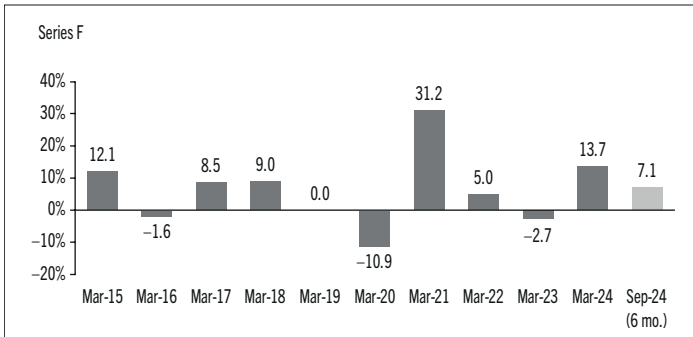
Year-by-Year Returns

Individual investors may be eligible for a management fee reduction subject to meeting certain requirements as discussed in the Fund's Simplified Prospectus.
- (6) This series is no longer available for sale. The series' original start date was May 25, 2017. On October 27, 2023, Series Private Wealth I securities were redesignated as Series F securities, resulting in a consolidation of these series' assets.
