Management Discussion of Fund Performance

November 10, 2025

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments that have affected the performance and outlook of Counsel U.S. Growth (the "Fund") in the six-month period ended September 30, 2025 (the "period"). If the Fund was established during the period, "period" represents the period since inception.

In this report, "CLIML" and "the Manager" refer to Canada Life Investment Management Ltd., which is an indirect, wholly owned subsidiary of The Canada Life Assurance Company ("Canada Life"). The Manager has entered into a fund administration agreement with Mackenzie Financial Corporation ("Mackenzie"), an affiliate of the Manager and Canada Life, for administrative services. In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

Results of Operations

Investment Performance

The performance of all series in the current and previous periods is shown in the *Past Performance* section of the report. Performance will vary by series primarily because fees and expenses differ between series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Series Information* section of this report for the varying management and administration fees payable by each series. The following comparison to market indices is intended to help investors understand the Fund's performance relative to the general performance of the markets. However, the Fund's mandate may be different from that of the indices shown.

During the period, the Fund's Series A securities returned 18.3% (after deducting fees and expenses paid by the series). This compares with a return of 16.1% for the Fund's broad-based index, the S&P 500 Index, and a return of 26.0% for the Fund's narrow index, the Russell 1000 Growth Index. All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, which are not reflected in the index returns.

U.S. equities rebounded sharply over the period following early volatility. The rebound was supported by robust corporate earnings and more accommodative monetary policy. The U.S. Federal Reserve reduced the federal funds rate by 25 basis points in September, to a target range of 4.00%–4.25%, amid slowing employment growth and elevated inflation. As tariff and central bank policy uncertainty eased, market sentiment and investor risk tolerance improved. Currency movements reduced returns in Canadian dollar terms.

Within the Russell 1000 Growth Index, utilities, information technology and communication services were the best-performing sectors in Canadian dollar terms, while energy, consumer staples and real estate were the weakest.

The Fund outperformed the broad-based index, with stock selection in the industrials sector and underweight exposure to the health care sector contributing to performance, along with holdings in Taiwan. Stock selection in the consumer discretionary sector detracted from performance. Given the Fund's mandate, the return of the narrow index is a more meaningful comparison.

The Fund underperformed the narrow index, with stock selection in the consumer discretionary and communication services sectors detracting from performance, along with underweight exposure to the information technology sector. The Fund's cash position also detracted from performance as equity markets rose.

Conversely, stock selection in the industrials sector and underweight exposure to the health care sector contributed to performance relative to the narrow index, as did holdings in Taiwan and the Netherlands.

Over the period, the Fund deployed cash as the sub-advisor, Marsico Capital Management, LLC, found attractive opportunities, and exposure to the information technology sector increased. Changes to the portfolio included new positions in Citigroup Inc., The Walt Disney Co. and Booking Holdings Inc., and the elimination of the positions in Chipotle Mexican Grill Inc., KKR & Co. LP and Starbucks Corp.

Net Assets

The Fund's net assets increased by 20.6% during the period to \$291.8 million. This change was composed primarily of \$48.8 million in net income (including any interest and/or dividend income) from investment performance, after deducting fees and expenses, and an increase of \$1.1 million due to net securityholder activity (including sales, redemptions and cash distributions).

Fees and Expenses

The annualized management expense ratio ("MER") for each series during the period ended September 30, 2025, was generally similar to the MER for the year ended March 31, 2025. Total expenses paid vary from period to period mainly as a result of changes in average assets in each series. The MERs for all series are presented in the *Financial Highlights* section of this report.

Recent Developments

The sub-advisor ended the period with a cautiously optimistic outlook supported by ongoing consumer resilience, easing monetary policy and continued advances in the adoption and implementation of artificial intelligence. Concerns included tariffs, high home prices and the sub-advisor's expectation of slower employment gains. At period-end, the Fund had overweight positions in the financials, communication services and industrials sectors, and underweight positions in the information technology and health care sectors, relative to the narrow index.

Related Party Transactions

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to the Manager at the annual rates specified under *Series Information* in this report and as more fully described in the Simplified Prospectus. In return for the administration fees, the Manager pays all costs and expenses (other than certain specified fund costs) required to operate the Fund that are not included in the management fees. See also *Management Fees*.

Other Related Party Transactions

Series Private Wealth securities are issued on a prospectus-exempt basis to investors in discretionary managed account programs offered by IPC Securities Corporation, an affiliate of the Manager. As a result of these investments, the Fund is subject to large transaction risk as discussed in its Simplified Prospectus. The Manager manages this risk to reduce the possibility of any adverse effect on the Fund or on its investors, through such processes as requiring advance notice of large redemptions. At September 30, 2025, Series Private Wealth investors owned 23.7% of the Fund's NAV. As of September 30, 2025, the Manager had not received notice of any large redemptions. All related party transactions are based on the NAV per security on each transaction day.

The Fund did not rely on an approval, positive recommendation or standing instruction from the Counsel Funds' Independent Review Committee with respect to any related party transactions in the period.






Year-by-Year Returns

Any income distributions received from ETFs managed by affiliates of the Manager, with the intention of offsetting fees paid within those ETFs but which are not considered to be duplicative fees under regulatory requirements, are treated as waived expenses for MER purposes. The Manager may waive or absorb operating expenses at its discretion and stop waiving or absorbing such expenses at any time without notice.
- (3) The trading expense ratio ("TER") represents total commissions and other portfolio transaction costs incurred as an annualized percentage of daily average net assets during the period. - (4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. The value of any trades to realign the Fund's portfolio after a fund merger, if any, is excluded from the portfolio turnover rate.

Management Fees

The management fee for each applicable series is calculated and accrued daily as a percentage of its NAV. The Fund's management fees were used by the Manager to pay for the costs of managing the investment portfolio of the Fund and/or the underlying fund(s), as applicable, including providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sale of the investment portfolio, and providing other services.

The Manager is responsible for paying certain administrative costs, trailing commissions and any other compensation (collectively, "distribution-related payments") out of management fees to IPC Securities Corporation, IPC Investment Corporation and Quadrus Investment Services Ltd. (collectively, the "Principal Distributors," individually, a "Principal Distributor") and authorized dealers whose clients invest in the Fund. The Principal Distributors and IG Wealth Management Inc. (an authorized dealer affiliated with the Manager) may be entitled to distribution-related payments from the Manager on the same basis as unrelated authorized dealers.

The Manager used approximately 38% of the total management fee revenues received from all Counsel Funds during the period to fund distribution-related payments to the Principal Distributors and authorized dealers. In comparison, such distribution-related payments for the Fund represented on average 29% of the management fees paid by all applicable series of the Fund during the period. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions paid for that series. The lower proportion of distribution-related payments is primarily attributable to the lower proportion of retail investors in series that pay a trailer fee compared to other funds managed by CLIML.
