# **Management Discussion of Fund Performance**

November 10, 2025

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments that have affected the performance and outlook of IPC Private Wealth Visio Income Pool (the "Fund") in the six-month period ended September 30, 2025 (the "period"). If the Fund was established during the period, "period" represents the period since inception.

In this report, "CLIML" and "the Manager" refer to Canada Life Investment Management Ltd., which is an indirect, wholly owned subsidiary of The Canada Life Assurance Company ("Canada Life"). The Manager has entered into a fund administration agreement with Mackenzie Financial Corporation ("Mackenzie"), an affiliate of the Manager and Canada Life, for administrative services. In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

## Results of Operations

### **Investment Performance**

The performance of all series in the current and previous periods is shown in the *Past Performance* section of the report. Performance will vary by series primarily because fees and expenses differ between series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Series Information* section of this report for the varying management and administration fees payable by each series. The following comparison to market indices is intended to help investors understand the Fund's performance relative to the general performance of the markets. However, the Fund's mandate may be different from that of the indices shown.

During the period, the Fund's Series A securities returned 3.1% (after deducting fees and expenses paid by the series). This compares with a return of 8.0% for a blended index composed of a 60% weighting in the Fund's broad-based index, the FTSE Canada Short Term Bond Index (returned 1.8%), a 27% weighting in the MSCI World (Net) Index (returned 15.7%) and a 13% weighting in the S&P/TSX Composite Index (returned 22.1%). All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, which are not reflected in the index returns.

Global equities performed well over the period as shares of U.S. mega-capitalization companies involved in artificial intelligence ("AI") reached new highs. Continued AI investment, robust corporate earnings and a weakening U.S. dollar also supported global investor sentiment. Canadian equities advanced amid resilient commodity prices. In September, the Bank of Canada reduced its policy rate by 25 basis points, to 2.50% from 2.75%, reflecting slowing economic growth, moderating inflation and rising unemployment.

Within the MSCI World (Net) Index, Africa and the Middle East and North America were the best-performing regions in Canadian dollar terms, while Europe and Asia Pacific (ex Japan) were the weakest. The information technology, communication services and industrials sectors were the strongest performers, while health care, energy and consumer staples were the weakest.

Within the S&P/TSX Composite Index, materials, information technology and financials were the best-performing sectors, while consumer staples, industrials and health care were the weakest.

The Fund outperformed the broad-based index because of its allocation to equities, which outperformed fixed income in the period. Given the Fund's mandate, the return of the blended index is a more meaningful comparison.

The Fund underperformed the blended index. The Fund's asset allocation contributed to performance, while the selection of underlying funds within each asset class detracted from performance.

Among the underlying funds in the portfolio, the largest detractors from relative performance were IPC Private Wealth Visio North American Equity, Counsel Canadian Value and Sagard Private Credit LP. Counsel Canadian Value replaced IPC Private Wealth North American Equity in the portfolio, and represented 27.0% of net assets at period-end. Sagard Private Credit LP represented 2.7%.

The largest contributor to relative performance was Counsel Core Fixed Income (representing 44.7%).

Other changes to the portfolio included the elimination of the allocation to Vanguard Canadian Long-Term Bond Index ETF.

#### **Net Assets**

The Fund's net assets increased by 263.8% during the period to \$207.2 million. This change was composed primarily of \$7.6 million in net income (including any interest and/or dividend income) from investment performance, after deducting fees and expenses, and an increase of \$142.7 million due to net securityholder activity (including sales, redemptions and cash distributions).

### **Fees and Expenses**

The annualized management expense ratio ("MER") for each series during the period ended September 30, 2025, was generally similar to the MER for the year ended March 31, 2025. Total expenses paid vary from period to period mainly as a result of changes in average assets in each series. The MERs for all series are presented in the *Financial Highlights* section of this report.

## Recent Developments

The portfolio management team believes that global growth trends diverged in the period, with the U.S. economy resilient while Canada, Europe and the United Kingdom were weighed down by rising unemployment and trade tensions. In the team's view, opportunities remained concentrated in the United States in a context of global economic fragility, and this uneven backdrop underscores the importance of diversification.

The Fund balances core U.S. equity exposure with global diversification and multifactor strategies that reduce dependence on narrow market leadership. Within fixed income, the team believes alternatives such as private credit can be valuable sources of income and duration management (sensitivity to changes in interest rates), particularly in a "higher-for-longer" environment in which central bank policy rates reflect persistent inflation. The team believes the Fund's liquidity and flexibility should help mitigate potential risks related to AI investment, funding markets and fiscal policy.

Effective August 26, 2025, underlying fund IPC Private Wealth Visio Core Fixed Income was renamed Counsel Core Fixed Income.

### Related Party Transactions

### **Management and Administration Services**

For each applicable series, the Fund paid management fees and administration fees to the Manager at the annual rates specified under *Series Information* in this report and as more fully described in the Simplified Prospectus. In return for the administration fees, the Manager pays all costs and expenses (other than certain specified fund costs) required to operate the Fund that are not included in the management fees. ### **Other Related Party Transactions**

At September 30, 2025, the Fund had \$5.6 million (2.7% of the Fund's NAV) invested in private funds managed by Sagard Holdings Inc., a company affiliated with the Manager. In making the investment(s), the Manager relied on an approval from the Counsel Funds' Independent Review Committee. The Independent Review Committee issued the approval on the basis that the investment(s) would be made in compliance with the Manager's policies. The Manager's policies are designed to ensure that any related party transaction (i) is made free from any influence by an entity related to the Manager and without taking into account any considerations relevant to an entity related to the Manager; (ii) represents the business judgment of the Manager, uninfluenced by considerations other than the best interests of the Fund; and (iii) achieves a fair and reasonable result for the Fund.

At September 30, 2025, the Fund had \$30.3 million (14.6% of the Fund's NAV) invested in underlying funds managed by Mackenzie. In making the investment(s), the Manager relied on a standing instruction from the Counsel Funds' Independent Review Committee. The Manager's policies are designed to ensure that any related party transaction (i) is made free from any influence by an entity related to the Manager and without taking into account any considerations relevant to an entity related to the Manager; (ii) represents the business judgment of the Manager, uninfluenced by considerations other than the best interests of the Fund; and (iii) achieves a fair and reasonable result for the Fund.

Segregated fund policies issued by Canada Life may invest in the Fund on a prospectus-exempt basis in accordance with the investment objectives of those funds. As a result of these investments, the Fund is subject to large transaction risk as discussed in its Simplified Prospectus. The Manager manages this risk to reduce the possibility of any adverse effect on the Fund or on its investors, through such processes as requiring advance notice of large redemptions. At September 30, 2025, these segregated funds owned 68% of the Fund's NAV. As of September 30, 2025, the Manager had not received notice of any large redemptions. All related party transactions are based on the NAV per security on each transaction day.

During the period, the Fund received \$0.02 million in income distributions from investments in exchange-traded funds ("ETFs") managed by Mackenzie to offset fees paid within those ETFs.


### **Past Performance**







# **Management Fees**

The management fee for each applicable series is calculated and accrued daily as a percentage of its NAV. The Fund's management fees were used by the Manager in part to pay Mackenzie, an affiliate of the Manager, for investment advisory services, including managing the investment portfolio and providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sale of the investment portfolio, and providing other services.

The Manager is responsible for paying certain administrative costs, trailing commissions and any other compensation (collectively, "distribution-related payments") out of management fees to IPC Securities Corporation, IPC Investment Corporation and Quadrus Investment Services Ltd. (collectively, the "Principal Distributors," individually, a "Principal Distributor") and authorized dealers whose clients invest in the Fund. The Principal Distributors and IG Wealth Management Inc. (an authorized dealer affiliated with the Manager) may be entitled to distribution-related payments from the Manager on the same basis as unrelated authorized dealers.

The Manager used approximately 38% of the total management fee revenues received from all Counsel Funds during the period to fund distribution-related payments to the Principal Distributors and authorized dealers. In comparison, such distribution-related payments for the Fund represented on average 42% of the management fees paid by all applicable series of the Fund during the period. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions paid for that series. The higher proportion of distribution-related payments is primarily attributable to the higher proportion of retail investors in series that pay a trailer fee compared to other funds managed by CLIML.
